## North State Giving Tuesday December 1

Now that SEA has been in existence for two years, we qualified for participation in North State Giving Tuesday on December 1st this year from 6 am to 8 pm -- 14 hours for the community to come together to raise as much as possible for participating organizations. This online event provides nonprofits the opportunity to gain exposure and start relationships with new donors. ### Sulphur Creek Cleanup: A Success



Shasta Environmental Alliance cleaned up several hundred yards of Sulphur Creek of plastic bottles, bags, cans, old camping supplies, metal, two old tires and assorted debris. This was all the area of the creek where the rare plant, Sulphur Creek Brodiaea grows on McConnell Foundation Property. We did not cleanup a homeless camp on another branch of the creek where the rare plant does not grow. That will be a future project for the City. Penny Harris also repurposed the two tires for a garden project she is working on.

We only had five people show up, but that was enough for us to finish the planned section in about two hours. Those participating were Bob Madison, Chris Harvey, Penny Harris, Melissa Harbert and David Ledger. Everyone kept on their face masks unless working at a distance.

A special thanks to Joey Forseth of Redding Parks and Recreation for loaning us buckets, trash grabbers and trash bags. Sports LTD donated a number of prizes and gift certificates as did Sprouts Farmers Market in Redding. We will be giving these out to participants and those helping in future cleanups.

## Creek cleanup on your own schedule:

Do you want to cleanup a section of Sulphur Creek or you own favorite creek or trail? We can arrange that too and assign you to another area where you can work on your own schedule. Just contact us and we will see if we can get some supplies to you, or you can use your own. This is the type of cleanup various environmental groups are conducting throughout California, allowing people to be clean up our environment while being COVID safe.

We will have a sheet for you to keep a count of what types, amounts, and weights of trash you have collected and we can compare over the years. Gift certificates from **Sports LTD** and **Sprouts Farmers Market** will be given for: 1. the best photo; 2. the most trash collected; 3. the most unusual item; and 4. the largest item. Everything eventually ends up in the ocean, so this is a part of the Coastal Cleanup. Please participate and do your part!

## **City of Redding Street Tree List Approved SEA Tree Committee provided input**

Using substantial input from SEA's Tree Committee the City of Redding has updated its Street Tree List. The Tree Committee met a number of times before coming up with a list of trees we recommended to be added to the tree list and a few recommended for removal. Most, but not all of our recommendations were accepted. The committee consisted of Rico Montenegro, Lemoine Waite, John Alderson, Kirkwood Hale, Michael Lander, Doug Mandel, Susan Gallaugher, Aleta Carpenter and David Ledger.

In the future we hope to come up with a recommended list of trees for new subdivisions. Too many new homes are ending up with the required shade trees being crepe myrtles, redwoods and/or palm trees. We plan on a list of 20 to 30 trees that can adapt to Redding's climate.

# North State Climate Plea presented to Redding City Council

The North State Climate Plea on climate change was presented to the Redding City Council on October 17 by Dan Greaney of North State Climate Action (NSCA). About 800 signatures have been collected by NSCA and SEA and about 40 people on the SEA and NSCA email lists sent in letters of support of our petition. Forty emails is a lot for the City Council to receive on an issue and most people who sent one received an email from Erin Resner and Julie Winter.

Climate Change was a question on SEA's Redding City Council Candidate's Questionnaire and Winter stated she accepted the science of climate change and the need to increase Redding's tree canopy. In conjunction with Greaney presenting the petition to the City Council, SEA President David Ledger gave a short presentation on the heat island effect and the need for Redding to increase its tree canopy to counteract the heat island effect.

Sometimes it is hard to think of what to say to express yourselves in a short email to the City Council, but all were well written, whether 25 words or several pages. Keep this in mind as SEA should be presenting our petition for a new Tree Ordinance petition to the Redding City Council in January and we hope to have even more emails in support of saving Redding's trees.
