Shasta Lake Planning Commission Approves Weak Tree Conservation Ordinance

The Shasta Lake Planning Commission approved a disappointingly weak and inadequate Tree Conservation Ordinance at its September 3 meeting. Now the ordinance will go the Shasta Lake City Council for approval, rejection or revision.

While the ordinance does require mitigation for removal of oak trees, it is greatly inadequate. It will require the planting of three trees of any species for each oak tree removed, whether the trunk has a diameter of 10 inches or 40 inches. This would allow the planting of any trees, for example, three crape myrtles, or a small mitigation fee.

Shasta Lake hired Jim Hamilton, a private consultant, to rewrite the ordinance. Hamilton was previously head of the City of Redding Development Resource Department and oversaw the rewrite of the current Redding Tree Management Ordinance. Many of the Shasta Lake Planning Commissioners are new and relied on Hamilton for advice on their questions about the ordinance. One of those questions was the low fine for cutting down a tree without a permit. He implied that this was all the City could charge, although other cities charge more; for example, the City of Chico has a \$5000 fine.

The only persons opposing the new ordinance were Shasta Lake activist Pat Lind, SEA Tree Committee member Rico Montenegro, and Sea President David Ledger. SEA will put out a notice before this reaches the City Council so that SEA supporters can attend.

SEA Sulphur Creek Cleanup Trash Cleanup on October 17

Shasta Environmental Alliance will be leading a creek cleanup on October 17 in a section of Sulphur Creek where the rare Sulphur Creek Brodiaea grows. This will be a COVID-safe event, following social distancing safety guidelines, with the group cleanup limited to a maximum of 10 people.

A second option will be offered to individuals and family units to clean up a section of Sulphur Creek in the Redding Arboretum area. You will have a form to fill out listing the types of trash you collected and the approximate weight. We are asking that you place the trash in your own curbside carts, although we are seeking permission from the City for free dumping of the group cleanup.

We will have some cleanup supplies such as trash bags, gloves and five-gallon buckets available. There will be a prize of a \$25 gift certificate from Sports LTD for the person or party collecting the most trash. For more information, email ecoshasta@gmail.com.

Still No Action by Planning Department on Oak Tree Removal Near McConnell Foundation

We are still waiting for the Redding Planning Department to respond to our complaint of May 5 regarding the removal of trees on a large lot near the McConnell Foundation Churn Creek trails. According to the Planning Department, no tree removal permits were issued for the lot in question, but no action has been taken by Planning as yet. It increasingly appears that the Redding Tree Management Ordinance is a paper tiger in preserving any trees in Redding. SEA has recently turned in several other lots where it appears the owners may have jumped the gun and removed trees without a permit.

Fountain Wind Project Comment Period extended to October 5 on Draft EIR

Shasta County Planning Commission recently sent out a notice that the deadline to comment on the Fountain Wind Project near Montgomery Creek has been extended to October 5.

The approximate 4,464-acre proposed project site is located within an approximately 29,500acre section consisting exclusively of private property operated as managed forest timberlands. The project will have 72 wind turbines, each 679 feet tall, located approximately one mile west of the existing Hatchet Mountain Wind Farm

The project would have a maximum total generating capacity of up to 216 MW. Copies of the Draft EIR are now available for public review at

There is a grassroots organization opposed to the project: Citizens In Opposition to the Fountain Wind Project (CIO FWP) whose website is <u>www.stopfw.com</u>. Until COVID-19 they had been holding regular community meetings. They continue to speak out at Shasta County Supervisors and Planning Commission meetings.

Recycling Batteries, the How and Where By Christina Piles

Most people know that household batteries should not be disposed of in the garbage. They contain many different hazardous metals and have been banned from the landfill. Fortunately, there are several options for Shasta County residents to properly recycle their used household batteries.

The City of Redding Household Hazardous Waste Facility accepts household batteries from residential customers in Shasta County, Tuesday - Saturday from 9 am to 4 pm. County residents can also drop off their batteries at any one of the three Ace Hardware stores in Redding. Batteries can be dropped off for recycling in any type of container or bag if you use any of the above recycling locations. As a result of these programs, 33,986 pounds of batteries were recycled in 2019.

If you are a City of Redding Solid Waste customer, you can also recycle your batteries by placing them in a special, heavy-duty orange bag that is available at ten locations within the city and placing the filled bag <u>inside</u> your blue recycling cart. Please do not use any other type of bag, as they will break during the sorting process, preventing the batteries from being recycled. The orange battery recycling bags can only be used in City carts, not carts serviced by Waste Management. A list of locations and addresses for both the bags and Ace Hardware stores that accept batteries can be found by going to

Since lithium-ion batteries can heat up and catch fire if damaged, they should never be placed into your curbside carts. We recommend that you keep them separate from other batteries and bring them to the Household Hazardous Waste Facility. 9V alkaline batteries should have the terminals taped as these can also cause fires if the terminals come into contact with other 9V batteries. If you generate button batteries, such as the types that are used in hearing aids, please place the spent batteries back into the packaging they came in before dropping them off to be recycled.

The US Forest Service is seeking volunteer members for the Shasta County Resource Advisory Committee (SCRAC). Committee members are responsible for choosing which locally developed projects get funded for work on our local National Forest lands.

They are seeking representatives from various sectors of the public, such as teachers, unions, forestry, environmental groups, grazing permit holders, and the general public. It will involve about three meetings per year and one field trip. With COVID, meetings may be held via Zoom or similar programs.

The funding is provided by The Secure Rural Schools Program (SRSP) and committee members will assign points to various grants in Shasta County that are submitted, ranging from trail building, outdoor education, to tree planting. About \$200,000 in funds will be allocated by the committee
