As this was our first event, we were happy with the turnout in which several people thought there were 120 or more people. We kept it simple, just buying finger foods, coffee, lemonade and tea. Each awardee was given a framed award from SEA and then Mayor Julie Winter, who was unable to attend, arranged for and signed certificates of accomplishments from the City of Redding for all of those honored. Kim Niemer, Director of Redding Community Services, introduced Peggy Rebol and presented her with the Mayor's award as Kim has worked with Peggy on the Whole Earth and Watershed Festival over many years.

This was a fun event and we received many words of appreciation for organizing it and how much people enjoyed the event. We collected \$600 in donations with about \$450 in expenses.

E-Bikes on BLM and National Park Trails

The California Wilderness Coalition is concerned about recent efforts by

Secretary David Bernhardt and the Department of the Interior to non-motorized trails on BLM and National Parks trails. Bernhardt who was formerly a lobbyist for the Westlands Water District and attorney for various fossil fuel companies has apparently decided to bypass the regular planning process and NEPA analysis. On August 29th, Secretary Bernhardt issued Secretarial Order (SO) No 3376. In this letter he outlined his desire for all Interior Department agencies

including BLM, U.S.Fish and Wildlife, and National Park Service to allow "Class 1", the least motor assisted, e-bike use on any trail or road where non-motorized mountain bikes are currently allowed. Shasta County Approves Going Solar on County Facilities

On December 10 the Shasta County Board of Supervisors voted to install solar power with battery backup on almost all of their County buildings. David Ledger from Shasta Environmental Alliance; John Livingston of the Shasta Group of Sierra Club; Steve Marsh and Ron Dykstra of North State Climate Action among others spoke in support of this proposal by the County which besides cutting down on greenhouse gases will lower their energy costs. WATER Starts Single Use Plastics Campaign in Siskiyou County

W.A.T.E.R.: Our Sisikiyou County SEA supporting group WATER has started a campaign and online petition in the Mt. Shasta area against single use plastics containers. They estimate if the Crystal Geyser plant is approved, it will produce over one million plastic bottles per day. WATER is the group that has been fighting the proposed new Crystal Geyser water bottling plant in Mt. Shasta. SEA/CNPS Blue Oak Acorn Planting in Carr Fire Burn Area

Secondary Succession Following the Carr Fire in Chaparral and Oak Woodlands (with Acorn Planting). This will be a joint CNPS and Shasta Environmental Alliance fieldtrip on a three mile walk through a burned area of the Carr Fire that will include the planting of 200 or more blue oak acorns and a few gray pine seeds. Walk leader David Ledger will identify different plants on the trail and note their responses to fire and the probable progression of vegetation recovery of the area over the next 10 years. Bring a hand trowel to help plant acorns and seeds. It will take about 30 to 45 minutes to plant the seeds; the rest of the time will be spent walking a trail and seeing how different chaparral and oak woodland plants are recovering. For light rain or sprinkles, bring raincoat or umbrella; heavier rain cancels. Sorry, no dogs on this fieldtrip. Meet in the Placer Street Holiday Market parking lot near CVS at 9:30 am. Solar Power Redding City Council Vote Tuesday, December 18, 6 pm

On December 17th at 6pm, the Redding City Council will decide the future of citizens' opportunities to invest in solar energy here, in the second sunniest city in the United States. The staff proposal from Redding Electric Utility is to cut the net energy metering credit by 60%, to just about six cents per kilowatt hour. We encourage citizens to email or phone city council members before the meeting, and attend the meeting and speak in favor of the 12 cent compromise rate suggested by local Redding solar contractors.

If you already have solar, your rates will not be affected by REU's proposal; but we encourage you to speak out and ask City Council to protect the right of other citizens to invest in their own solar system in Redding. City Council can do that by approving a net metering rate of at least twelve cents per kilowatt hour. It is a reasonable compromise. And it will ensure that solar users' extra energy is fairly valued. Seeking people to speak out in support of solar power at the hearing.
