Turtle Bay Surplus Land Decision Postponed: It Will Require a Riverfront Specific Plan and CEQA Review

As most of you know, those opposed to intensive development of the Redding riverfront at Turtle Bay won a victory at the April 19 Redding City Council meeting when the Council voted 4 to 1 to not list the public land as surplus. Instead, the Council voted on a motion by Council Member Erin Resner to first prepare a new Specific Plan for the area before making any decision on whether to list the land as Surplus Property. The process of developing a Specific Plan will take 18 to 24 months and SEA plans to be involved. This plan will be required to have a full environmental review under the California Environmental Protection Act (CEQA).

The Riverfront Specific Plan process will be explained to the public in two workshop sessions, then the City will hire an environmental consulting firm to draw up an updated Riverfront Specific Plan and they will accept input from the public before it is developed. SEA will be a part of the focus groups, according to City Manager Barry Tippin.

Everyone who spoke at the council meetings or sent in emails of opposition to the sale of land at Turtle Bay are to be commended as the opposition to selling the land to the D & D group was overwhelming. SEA, Wintu Audubon, and Sierra Club hired an attorney specializing in the California Environmental Quality Act (CEQA), who sent in a 11-page letter to the Council stating this would first require a CEQA review; this also had an effect on the Council decision.

Council Member Julie Winter was the only no vote, but she did propose that all natural areas to the east of the Sundial Bridge and riparian areas upstream of it be given permanent protection. This is something SEA will be working on in case the D &D group should later be able to purchase the property around the Civic and the rodeo grounds. During a meeting with SEA and Wintu Audubon, City Manager Barry Tippin said putting easements on the riparian areas and the undeveloped parcels is an option for the Council to consider.

Thanks again to all who sent in letters of opposition to the land sale or spoke in person. Your voices did make a difference in what was looking like the loss of public land to private developers. If you had not spoken out, developers would be deciding what happens at Turtle Bay.

North State Climate Action Alert:

Shasta County Planning to consider countywide ban on industrial wind farms

On April 14th, the Shasta County Planning Commission considered a resolution for ordinance changes prohibiting wind farms in all of unincorporated Shasta County, regardless of their potential merits.

Wind farms are a source of cheap, clean, renewable energy. They fight climate change, air pollution, and use much less water than fossil fuel power plants.

The Planning Commission continued the hearing until May 12th because they received a letter in opposition to the proposed changes from a clean energy sector attorney on the morning of the hearing stating that the County had not complied with CEQA (California Environmental Quality Act) by failing to perform an environmental review on this issue. This means that the comment period for this anti-wind farm ordinance will remain open until the Commission meets on May 12, 2022.
